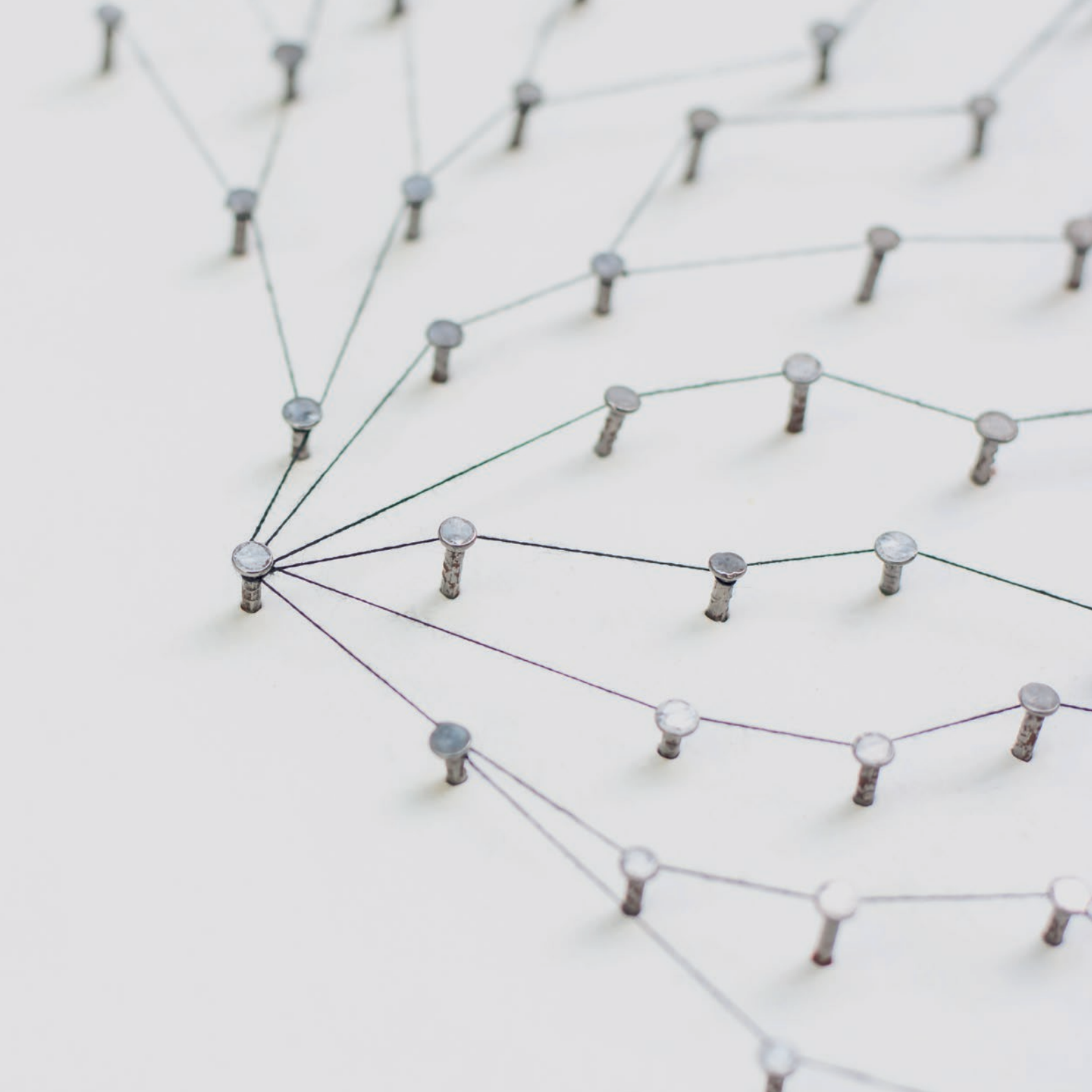


UHLMANN GROUP BEYOND PACKAGING
